Volunteering is a gratuitous, conscious and unpaid activity for the benefit of others, going beyond friendship and family relations.

The Role of Volunteers Ideological, ethical and moral reasons

The Role of Volunteers

Volunteering in Caritas Georgia

In Caritas Georgia volunteers have a possibility to help different persons in need. Programs of Caritas are working with such types of people as: orphans, refugees, homeless, lonely elderly, sick, socially vulnerable persons, victims of natural disasters and armed conflicts, children leaving on street, and many others.

Before the beginning of voluntary work in Caritas Georgia every volunteer has to get familiarized with the work of Caritas and its projects and actions. Volunteer is free to choose the field where he wants to work (from the presented variants) and in case of being accepted in the project, he has to follow the schedule, code of ethics and other conditions specified in his contract, job description, volunteer handbook or agreed verbally.

At the moment of acceptance in Caritas Georgia, volunteer receives:

- Contract
- Job description
- ☐ Volunteer ID card
- Volunteer handbook

This Code of Conduct specifies the attitudes and behavior that all Caritas volunteers are expected to maintain. The Code is derived from, and closely related to, the Caritas Code of Ethics which prescribes the basic values and institutional practices of Caritas organizations.

"Individuals who care for those in need must first be professionally competent: they should be properly trained in what to do and how to do it, and committed to continuing care. Yet, while professional competence is a primary, fundamental requirement, it is not of itself sufficient. We are dealing with human beings, and human beings always need something more than technically proper care. They need humanity. They need heartfelt concern."

1. Values, Conduct and Ethics

Adhere to or at least understand and respect the social and

_	moral values and teaching of the Catholic Church
	Ensure at all times that their personal and professional conduct is of the highest standards, and is seen to be so
	Act in good faith and treat other people with dignity and respect, creating an environment that celebrates diversity
	Respect all human rights and challenge discrimination, harassment, abuse, neglect, and exploitation that infringe the rights of others
	Respect the privacy of the beneficiaries (ex. not to take pictures without their permission): please be informed that pictures of children cannot be published on the media/social networks
	Avoid "impos[ing] one's faith upon others realiz[ing] that a pure and generous love is the best witness to the God in whom we believe and by whom we are driven to love" (Deus Caritas Est #31c)
	Refrain from making racist, sexist or otherwise offensive statements publicly or privately
	Take reasonable action to protect others from harm
	Observe the laws of the country in which they are working, within the bounds of conscience

All Caritas volunteers are expected to:



Respect and be sensitive to local customs and culture, dress accordingly			
Ensure that they, and any staff that they manage, act in accordance with health, safety and security guidelines, and endeavour to safeguard others			
Ensure that Caritas' reputation is not be brought into disrepute			
Maintain the confidentiality of any information or knowledge obtained during the exercise of their duties with Caritas			
Perform their duties competently and with love, without prejudice or discrimination of any form, and maintain Caritas' preferential option for the poor			
Keep in mind local sensitivities when expressing and practicing their respective beliefs

2. Conflicts of interest, coercion and corruption

- Avoid using positions of power conferred by their roles as Caritas volunteers to exert pressure, or extract favours or personal gain economically, professionally, politically or sexually
- Declare any potential or actual conflicts of interest (financial, personal or familial) in matters relating to Caritas' work to their supervisor or other senior manager in writing
- Refrain from accepting any favours, bribes or other forms of personal enrichment from beneficiaries, partners or contractors under any circumstances (In order to respect national and local traditions and conventional hospitality, minor token gifts can be accepted on behalf of Caritas but should be declared).



3. Protecting Caritas property and exercising stewardship

- Ensure that Caritas' assets and intellectual property are not misused and are protected from theft, fraud or other damage
- Maintain appropriate standards of honesty and integrity in financial accountability





4. Personal conduct

- Refrain from carrying of any weapons on any Caritas business or property (owned or rented) including accommodation/ office/vehicles etc.
- Refrain from using recreational drugs or consuming excessive quantities of alcohol
- Ensure that their sexual conduct is appropriate at all times

5. Voluntary activities

- Notify volunteer managers or volunteer coordinator of any issue that might affect their ability to perform their functions (health or other factors) or cause harm to themselves or others, as soon as possible and before the commencement of the voluntary work
- Report in advance any change in their conditions of volunteering

Breaches of the Code

Any breaches of the Code of Conduct will be investigated, and may lead to disciplinary measures.
